**11:00 AM** After completion of parade, help remove trash receptacles along parade route.

**Uniforms:** **Full Class A**

**Other Info:** Participating Scouts will earn service time hours. Be sure to bring sunscreen & water. **Adult participation is highly encouraged and requested.** However, only uniformed Scouts and leaders can walk in the parade. Kiwanis also has invited the scouts to attend breakfast before the parade and lunch after the parade at Pete's Brass Rail, 201 Hartz Ave, Danville. In the event I cannot be reached, I hereby give my permission to the medical provider selected by the adult leader in charge to secure proper treatment, including hospitalization, anesthesia, surgery, or injections of medication for my child. Medical providers are authorized to disclose to the adult in charge examination findings, test results, and treatment provided for purposes of medical evaluation of the participant, follow-up and communication with the participant's parents or guardian, and/or determination of the participant's ability to continue in the program activities. (All reasonable measures will be taken to safeguard the health and safety of the Troop's members.)
